SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT (this "Agreement") is made as of ______, by and among, DAVID DEWITT ("Dewitt") who is the owner of the real property hereinafter described, as well as the judgment debtor, SECURITY-CONNECTICUT LIFE INSURANCE COMPANY, (hereinafter the "Judgment Creditor"); and, NOVASEL & SCHWARTE INVESTMENT INC., DBA WESTERN HIGHLAND MORTGAGE CO., (hereinafter "Lender"), with respect to the following Recitals:

WHEREAS Judgment Creditor has obtained and recorded a civil judgment against DeWitt in Case No. 01-CV-0242, Ninth Judicial District Court of the State of Nevada, in and for Douglas County. The judgment is a lien against all real property owned by DeWitt in Douglas County, including the real property subject to this Subordination Agreement.

WHEREAS, DeWitt is the owner of the hereinafter described real property, and DeWitt desires to obtain a construction loan from Lender for the purpose of constructing a single family residence on the real property.

Lender desires to provide Dewitt with a construction loan in the amount of \$285,000.00 for purposes of the construction of the single family residence on the property, but will only do so if the Judgment Creditor subordinates its judgment lien to the construction loan.

The parties have agreed that the Judgment Creditor shall subordinate its judgment lien, in accordance with the terms and conditions hereinafter set forth.

NOW THEREFORE, it is agreed:

"THIS DOCUMENT, EXECUTED IN COUNTERPART, IS BEING RECORDED AS ONE DOCUMENT"

- 1. Judgment Creditor hereby subordinates its judgment lien to a promissory note and deed of trust, in favor of Lender, in an amount not to exceed \$300,000.00, and a term not to exceed 2 years.
- 2. DeWitt shall pay Judgment Creditor \$15,000.00 to be applied against the judgment as consideration for the Subordination.

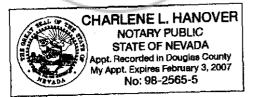
- 3. DeWitt shall pay Judgment Creditor the sum of \$600.00 per month representing the interest accruing on the judgment.
- 4. DeWitt shall pay the judgment in full on or before June 30, 2005.
- 5. That said deed of trust securing said note in favor of Lender, and any renewals or extensions thereof shall be and remain at all times a lien or charge on the property therein described, prior and superior to the lien or charge of the judgment lien first above mentioned.
- 6. That Lender would not make its loan above described without this subordination agreement.
- 7. That this agreement shall be the whole and only agreement with regard to the subordination of the lien or charge of the judgment lien first above mentioned to the lien or charge of the deed of trust in favor of lender above referred to and shall supersede and cancel, but only insofar as would affect the priority between the judgment lien and deed of trust hereinbefore specifically described, any prior agreement as to such subordination including, but not limited to, those provisions, if any, contained in the judgment first above mentioned above, which provide for the subordination of the lien or charge thereof to another deed or deeds of trust or to another mortgage or mortgages.
- 8. DeWitt consents to and approves (i) all provisions of the note and deed of trust in favor of Lender above referred to, and (ii) all agreements, including but not limited to any loan or escrow agreements, between Owner and Lender for the disbursement of the proceeds of Lender's loan;
- 9. Lender is making disbursements pursuant to any such agreement is under no obligation or duty to, nor has Lender represented that it will, see to the application of such proceeds by the person or persons to whom Lender disburses such proceeds and any application or use of such proceeds for purposes other than those provided for in such agreement or agreements shall not defeat the subordination herein made in whole or in part;
- 10. Judgment Creditor intentionally and unconditionally waives, relinquishes and subordinates the lien or charge of the judgment lien first above mentioned in favor of the lien or charge upon said land of the deed of trust in favor of Lender above referred to and understands that in reliance upon, and in consideration of, this waiver, relinquishment and subordination specific loans and advances are being and will be made and, as part and parcel thereof, specific monetary and other obligations are being and will be entered into which would not be made or entered into but for said reliance upon this waiver, relinquishment and subordination; and
