## STIPULATION FOR ENTRY OF JUDGMENT

IT IS HEREBY STIPULATED AND AGREED by and between CALIFORNIA CASUALTY GROUP, ("Plaintiff"), and ARNULFO CEBALLOS-MARTINEZ, ("Defendant(s)"), that Judgment be entered in favor of the Plaintiff and against the Defendant(s) for the amount of \$4,466.72, plus interest on the principal balance in the amount of \$140.73, along with Plaintiff's costs of suit in the amount of \$166.00, and Plaintiff's attorney's fees in the amount of \$250.00, together with interest on the principal balance at the statutory rate per annum from March 27, 2003 until this debt is paid in full.

It is further stipulated and agreed that this Judgment shall be paid as follows:
