thence North, 20.65 feet;

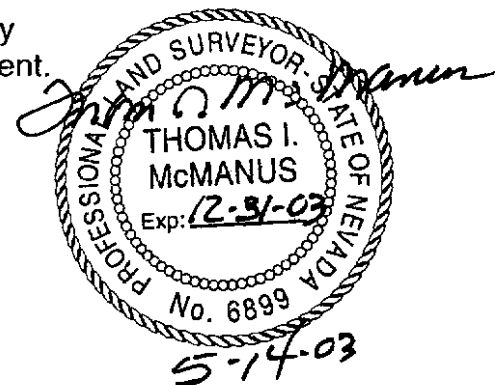
