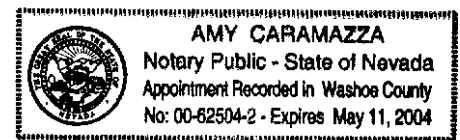

DESCRIPTION

All that real property situated in the County of Douglas, State of Nevada, bounded and described as follows:
