**AMENDMENT NO. ONE  
TO  
MEMORANDUM OF TENANCY-IN-COMMON AGREEMENT**

THE MEMORANDUM OF TENANCY-IN-COMMON AGREEMENT, dated as of the 1<sup>st</sup> day of January, 1998, by and between John N. Norris ("Jack"), as Trustee of the NORRIS FAMILY TRUST U/T/A dated June 14, 1991 ("Norris Trust"), and Robert L. Melton ("Bob"), as Trustee of the MELTON FAMILY TRUST U/T/A dated October 11, 1995 ("Melton Trust"), recorded in the Official Records of Douglas County, Nevada, February 13, 1998, Docket No. 0432643, Book 0298, Page 2421, is hereby amended as of the 1<sup>st</sup> day of January, 2003, as follows:

The parties are hereby amended to John N. Norris III ("Jack"), as Trustee of the NORRIS FAMILY TRUST U/T/A dated June 14, 1991, as amended ("Norris Trust"), as to an undivided fifty percent (50%) interest, and Robert L. Melton ("Bob"), as Trustee of the MELTON FAMILY TRUST U/T/A dated October 11, 1995, as amended - Survivor's Trust, and Robert L. Melton, as Trustee of the MELTON FAMILY TRUST U/T/A dated October 11, 1995, as amended - Survivor's Income Trust ("Melton Trusts"), as to an undivided fifty (50%) interest.

Except as herein amended, the provisions of the Memorandum of Tenancy-in-Common Agreement as originally written shall remain in full force and effect.

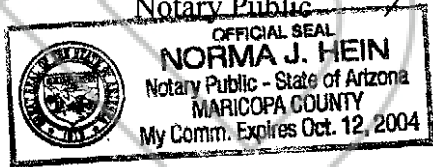

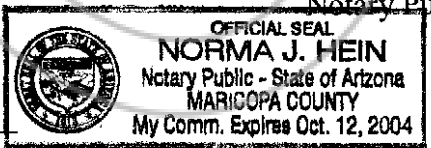
