
24 IT IS HEREBY ORDERED AND ADJUDGED that an amended
25 attorney's lien in favor of KATHLEEN B. KELLY, ESQ. is
26 established, adjudicated and granted, as is a personal judgment
27 against Cindy in favor of the Law Office of Kathleen B. Kelly,
28 in the sum of four thousand thrity-two dollars and fifty-five

1 cents (\$4,032.55) plus legal interest compounded monthly until
2 paid in full. Additionally, Cindy is also ordered to pay all
3 attorney's fees and costs incurred by her in pursuit of the
4 execution of this judgment.

6 IT IS FURTHER ORDERED AND ADJUDGED that the amended
7 attorney's lien and personal judgment against Plaintiff may be
8 placed of record upon Plaintiff's real or personal property and
9 the Law Office Kathleen B. Kelly, shall proceed with all
10 available execution remedies.
