TRUSTEE'S DEED

THIS DEED, is made this 11th day of August, 2003, by Walley's Partners Limited Partnership, a Nevada limited partnership, David G. Hyman, Authorized Agent, having a mailing address of P.O. Box 158, Genoa, Nevada 89411, herein Grantor, and WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership, herein Grantee.

Grantor is the trustee under the certain deed of trust dated November 16, 1999, executed by Susan V. Gonzales, an unmarried woman for the benefit of WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership having a mailing address of P.O. Box 158, Genoa, Nevada, 89411, which deed of trust was recorded in the Official Records of the County Recorder of Douglas County, Nevada, in Book 1199 at Page 4977 as Document Number 481615, hereinafter the Deed of Trust.

Grantor, as trustee under the Deed of Trust, did sell the Property at public auction at the time and place noticed for such sale on August 7, 2003, to Grantee, the highest bidder, for U.S. \$13,085.35, in cash, in full or partial satisfaction of the indebtedness secured by the Deed of Trust.


