IT IS THEREFORE ORDERED that judgment is entered in favor of Plaintiff Nevada State Bank and against Defendants Thomas Michael Hays and Lisa J. Hays, jointly and severally for: (1) \$2,490.34 plus interest accruing at 17.50% per annum from December 9, 1999, until paid in full; and (2) \$16,129.90 plus statutory interest accruing per annum from the date of entry of this Judgment until paid in full.

The court finds that there is no just reason for delay; this judgment is certified as final pursuant to NRCP 54(b).


The pretrial conference and trial settings are VACATED, as this case is now completed.

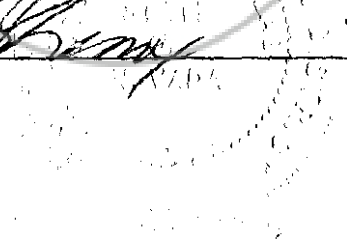
