APPOINTMENT OF SUBSTITUTE TRUSTEE

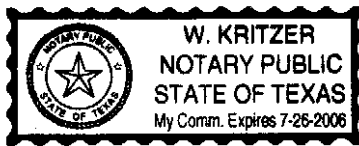
