16 **DEFAULT JUDGMENT**

17 BERRY-HINCKLEY INDUSTRIES having made application to this
18 Court for a default judgment against Defendants, HIGH SIERRA
19 STRUCTURES, INC. and GARY J. HILL, this Court finds as follows:

- 20 1. Plaintiff, BERRY-HINCKLEY INDUSTRIES, filed its
21 Complaint against Defendants, GARY J. HILL AND HIGH
22 SIERRA STRUCTURES, INC. (hereinafter "HILL" and "HIGH"),
23 on the 29th day of April, 2003.
- 24 2. Defendant, HILL, was served with a copy of the Summons
25 and Complaint herein on the 14th day of May, 2003, and
26 the Affidavit of Service is on file herein. Defendant,
27 HIGH, was served with a copy of the Summons and
28 Complaint herein on the 2nd day of May, 2003, and the

Affidavit of Service is on file herein.

3. Defendants, HILL and HIGH, and each of them, failed to timely answer the Complaint or make any other appearance in this matter.

4. On the 26th day of June, 2003, the Clerk of the Court entered Default against Defendants, HILL and HIGH.

5. Plaintiff, BERRY-HINCKLEY INDUSTRIES, sued to collect a debt owed to it by Defendants.

6. Defendants, HIGH and HILL, and each of them, jointly and severally, owe Plaintiff the amount of \$13,135.79 plus interest at 21% per annum on the sum of \$12,264.34 from March 31, 2003 until paid, plus \$1,506.50 for legal fees and costs, plus continuing legal fees and costs until the account is paid.

7. The law firm of TERRANCE SHEA, ESQ. rendered valuable and necessary legal services to Plaintiff in the reasonable amount of \$1,255.00, and the Plaintiff also incurred costs in this action in the amount of \$251.50. The total amount of legal fees and costs incurred by Plaintiff, to date, is \$1,506.50 and therefore, Plaintiff should be paid by Defendants \$1,506.50 plus any future legal fees and costs and expenses of collection incurred pursuant to the contract.

THEREFORE, JUDGMENT IS HEREBY ENTERED against Defendants, GARY J. HILL and HIGH SIERRA STRUCTURES, and each of them, jointly and severally, and in favor of Plaintiff, BERRY-HINCKLEY INDUSTRIES, in the amount of THIRTEEN THOUSAND ONE HUNDRED THIRTY-FIVE AND 79/100 DOLLARS (\$13,135.79), plus interest at

1 TWENTY-ONE PERCENT (21%) per annum on the sum of TWELVE THOUSAND,
2 TWO HUNDRED SIXTY-FOUR AND 34/100 DOLLARS (\$12,264.34) from March
3 31, 2003 until paid, plus ONE THOUSAND FIVE HUNDRED SIX AND
4 50/100 DOLLARS(\$1,506.50) for legal fees and costs, plus
5 continuing legal fees and costs until the judgment is satisfied.
6 Plaintiff's attorney(s) shall submit itemized statements of
7 attorney's fees and costs to the Court and the Court will amend
8 this judgment periodically to reflect those fees and costs
9 incurred by Plaintiff for collection of this judgment until the
10 judgment is satisfied.
