- 3. Defendants, HILL and HIGH, and each of them, failed to timely answer the Complaint or make any other appearance in this matter.
- 4. On the 26th day of June, 2003, the Clerk of the Court entered Default against Defendants, HILL and HIGH.
- 5. Plaintiff, BERRY-HINCKLEY INDUSTRIES, sued to collect a debt owed to it by Defendants.
- 6. Defendants, HIGH and HILL, and each of them, jointly and severally, owe Plaintiff the amount of \$13,135.79 plus interest at 21% per annum on the sum of \$12,264.34 from March 31, 2003 until paid, plus \$1,506.50 for legal fees and costs, plus continuing legal fees and costs until the account is paid.
