SECOND AMENDMENT TO DEEDS OF TRUST

THIS SECOND AMENDMENT TO DEEDS OF TRUST (this "Second Amendment"), dated as of August 22 2003 is entered into by and between:

- (1) BMC West Corporation, a Delaware corporation (the "Trustor"); and
- (2) Wells Fargo Bank, N.A., as agent under the Credit Agreement, as defined below (the "Administrative Agent" or the "Beneficiary").

RECITALS

- A. Pursuant to that certain Credit Agreement dated as of November 30, 1999, which was subsequently amended and restated pursuant to that certain Amended and Restated Credit Agreement, dated as of August 30, 2001 (collectively and as amended, restated or otherwise modified through the date hereof, the "Original Credit Agreement"), by and among, inter alia, the Trustor and the Administrative Agent, individually and as agent for the financial institutions which are a party thereto (the "Original Lenders"), Holdings, in its capacity as a borrower, obtained a line of credit consisting of term and revolving loans and a letter of credit subfacility in a maximum principal amount not to exceed \$300,000,000.00.
- B. The Trustor and the Administrative Agent, as successor-in-interest agent, concurrently with the execution of this Second Amendment, will (together with certain other parties thereto) (i) amend and restate the Original Credit Agreement pursuant to that certain Credit Agreement to be dated as of August 13, 2003, among (a) Holdings, (b) the Trustor, and certain other affiliates of Holdings, as guarantors, (c) the Lenders and (d) Wells Fargo Bank, N.A., as letter of credit issuing bank and swingline bank, as administrative agent for the Lenders and as lead arranger of the credit facilities described therein (as may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and (ii) increase the Aggregate Commitment available under the Credit Agreement to \$350,000,000.00.
- C. In addition, the Trustor and Bank of America, N.A., as agent for the Original Lenders, are parties to those certain Deeds of Trust listed on Schedule A attached hereto, and the Trustor and the Administrative Agent, as successor-in-interest agent, are parties to those certain

D. In connection with the Credit Agreement, the Trustor and the Administrative Agent have agreed to amend each of the Deeds of Trust as provided for herein.

AGREEMENT

- NOW, THEREFORE, in consideration of the above recitals and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Trustor and the Administrative Agent hereby agree as follows:
- 1. <u>Definitions, Interpretation</u>. All capitalized terms defined above and elsewhere in this Second Amendment shall be used herein as so defined. Unless otherwise defined herein, all other capitalized terms used herein shall have the respective meanings given to those terms in <u>Section 1.01</u> to the Credit Agreement.
- 2. <u>Amendment to Deeds of Trust</u>. The Deeds of Trust are hereby amended by amending and restating <u>Subsection 1.2(a)</u> of each Deed of Trust to read in its entirety as follows:
 - "(a) Payment of all obligations at any time owing under that Credit Agreement dated as of August 13, 2003, (as amended, restated or otherwise modified from time to time, the "Credit Agreement") owed by Trustor in the maximum stated principal amount of *Three Hundred Fifty Million Dollars* (\$350,000,000.00) to the Lenders and bearing a final maturity of August 21, 2010; and"
- 3. <u>Amendment of Defined Term.</u> All references to the word "Banks" in the Deeds of Trust are hereby amended to be "Lenders".
- 4. <u>Effective Date.</u> The amendments effected by <u>Paragraph 2</u> and <u>Paragraph 3</u> above shall become effective on the "Effective Date" as defined in the Credit Agreement, subject to satisfaction of the conditions set forth therein.
- 5. Effect of this Amendment. On and after the Effective Date, each reference in the Deeds of Trust and the other Loan Documents shall mean the Deeds of Trust as amended hereby. Except as specifically amended above, (a) the Deeds of Trust shall remain in full force and effect and are hereby ratified and affirmed and (b) the execution, delivery and effectiveness of this Second Amendment shall not, except as expressly provided herein, operate as a waiver of any right, power, or remedy of the Trustor or the Administrative Agent, nor constitute a waiver of any provision of the Deeds of Trust.

6. Miscellaneous.

(a) <u>Counterparts</u>. This Second Amendment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which taken together shall

constitute one and the same instrument. The signature page and acknowledgment of any counterpart may be removed therefrom and attached to any other counterpart to evidence execution thereof by all of the parties hereto without affecting the validity thereof.

- (b) <u>Headings</u>. Headings in this Second Amendment are for convenience of reference only and are not part of the substance hereof.
- (c) <u>Governing Law</u>. This Second Amendment shall be governed by and construed in accordance with the laws of the State which governs the applicable Deed of Trust, without reference to conflicts of law rules.
