

DEFAULT ORDER AND  
JUDGMENT

14 \_\_\_\_\_ /  
15 This Court has reviewed Plaintiff's Application for Default Judgment and all  
16 pleadings and papers on file herein, and makes the following findings and order by way  
17 of default:

18 **AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:**

19 That the court has jurisdiction over the parties and the subject matter of this  
20 case.

21 That Defendant was personally served with a cop of the Notice of Finding of  
22 Financial Responsibility (Paternity), a blank Response to finding of Financial  
23 Responsibility, and a blank Financial Declaration on June 16, 2003.

24 The Defendant has failed to answer, request a meeting with the Douglas County  
25 District Attorney's Office Child Support Division, or otherwise appear in this matter after  
26 properly served.

27 That the Defendant is the parent of, and owes a duty of support to Alexander  
28 Patrick Corrie Arthur, born August 6, 2001.

1 That based upon the affidavit submitted in support of the Application of Default  
2 Judgement, the presumed Nevada average wage pursuant to NRS 425.360(3) for the  
3 Defendant is \$2,754.26 per month. That based upon Defendant's presumed monthly  
4 income and applying the formulas set forth in NRS 125B.070, to wit 18%, Defendant's  
5 monthly child support obligation is \$496.00 and Defendant owes child support arrears in  
6 the amount of \$2,480.00 for the period of March 2003 though and including July 31,  
7 2003.

8 **THEREFORE, IT IS HEREBY ORDERED THAT:**

9 That Defendant is the parent of, and owes a duty of support for, Alexander  
10 Patrick Corrie Arthur, born August 6, 2001.

11 Judgment is entered in favor of Nik Ta and against Defendant Joseph Corrie  
12 Arthur in the amount of \$2,480.00 for the period of March 2003 through and including  
13 July 31, 2003.

14 That Defendant pay \$545.00 per month by wage withholding as follows:

15 CHILD SUPPORT:	\$496.00
16 CHILD SUPPORT ARREARAGE PAYMENT:	\$ 49.00
17 TOTAL:	<u>\$545.00</u>

18 **PAYMENTS MUST BE MADE AS FOLLOWS:**

19 That Defendant's monthly child support payments shall be in the form of a  
20 cashier's check, certified check, money order, or cash. If the payment is in the form of  
21 cash, it must be delivered to the Douglas County Clerk at her office in Minden, Nevada.  
22 If the payment is in the form of a cashier's check, certified check, or money order it  
23 must be made payable to SCaDU and must contain the notation UPI Number  
24 486378000 (Arthur, Joseph Corrie) and be mailed to SCaDU, Post Office Box 98950,  
25 Las Vegas, Nevada 89193-8950.

26 That Defendant secure and maintain medical health insurance on the above  
27 named child when available through employment or other group policy. The Defendant  
28 is ordered to provide to the Douglas County District Attorney's Office Child Support

1 Division information regarding the availability of health insurance.

2 The Defendant shall notify the Douglas County District Attorney's Office of any  
3 change in Defendant's home address, mailing address, telephone number,  
4 employment, or medical insurance availability within ten (10) days of any change.

5 In accordance with 125B.055, Plaintiff and Defendant are hereby ordered to file  
6 with the Court and with the District Attorney's Office their social security numbers,  
7 residential and mailing addresses, telephone numbers, driver's license numbers, and  
8 the name address and telephone number of their employers.

9 **IT IS FURTHER ORDERED THAT:**

10 That Defendant's first monthly child support obligation shall be due on the 1<sup>st</sup> day  
11 of August 1, 2003, and shall continue due on the 1<sup>st</sup> day of each and every month  
12 thereafter until further order of the court.

13 Pursuant to NRS 125B.100, a Defendant who, at the time the child becomes  
14 emancipated, is delinquent in the payment of support for the child pursuant to an order  
15 of a court for support, shall continue to make the payments for the support as  
16 previously ordered until the arrearages are paid in full.

17 That Defendant's ordered monthly payment on child support arrearages does not  
18 preclude other methods of collection for child support arrearages which may include,  
19 but are not limited to, wage withholding, garnishments, liens and the intercept of  
20 Federal Income Tax refunds, which will be undertaken upon entry of this order.
