Witnesseth:



All rights, title, and interest in and to a portion of Permit 61760, being 2.02 acre-feet annually, on file at the State of Nevada, Division of Water Resources.

TOGETHER WITH, all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, all and singular, the said water rights with the appurtenances, unto the said Grantees, and to their heirs, successors and assigns forever.

IN WITNESS WHEREOF, the grantors have hereunto executed this Water Rights Quitclaim Deed the day and year first written above.



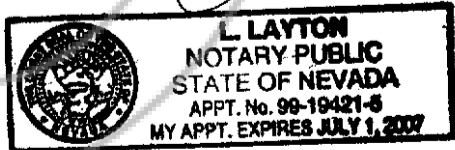
