This matter came on before the Court upon the Ex Parte Application for Personal and Financial Restraining Orders, which was filed by the Plaintiff, NADIA JACQUELINE ESPARZA (Nadia). The court being full advised in the matter and good cause appearing therefore;

IT IS HEREBY ORDERED as follows:

1. That the distribution of funds currently held in escrow shall be prohibited without Nadia's express prior written consent.

2. The parties shall be mutually restrained from transferring, encumbering, hypothecating, concealing, or in any

1 way disposing of any property, real or personal, whether
2 community or separate, except in the usual course of business or
3 for the necessities of life; and from incurring any debt for
4 which the other party may be liable during the pendency of this
5 action. In the event either party commits an act of waste of
6 community assets, that party shall be solely liable for any such
7 debt.
8

9 3. That neither party shall cancel any existing insurance
10 policies.

11 4. That Nadia's separate property currently located in the
12 marital residence be immediately returned to Nadia.

13 IT IS SO ORDERED.
