THIS RESCISSION OF NOTICE OF DEFAULT AND ELECTION TO SELL is made this 28TH day of October, 2003, by the undersigned.



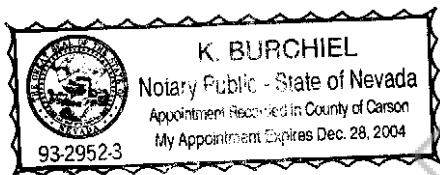
