THIS INDENTURE, made this 25th day of October, 2003 between WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership, Grantor, and JOSE M. SOLORIO-RUIZ and ANTONIA SOLORIO husband and wife as joint tenants with right of survivorship Grantee;

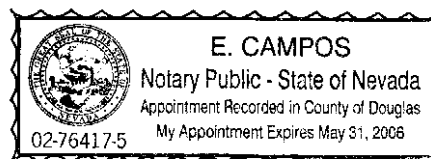
