CONVEY TO: DOUGLAS D. JORDAN, an unmarried man

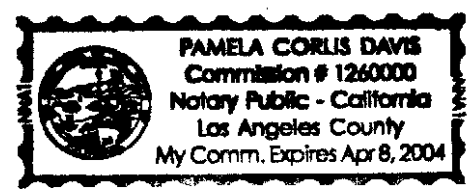
