
- (a) All amounts at any time owing by the undersigned to Lender under any provisions of the Loan Agreement;

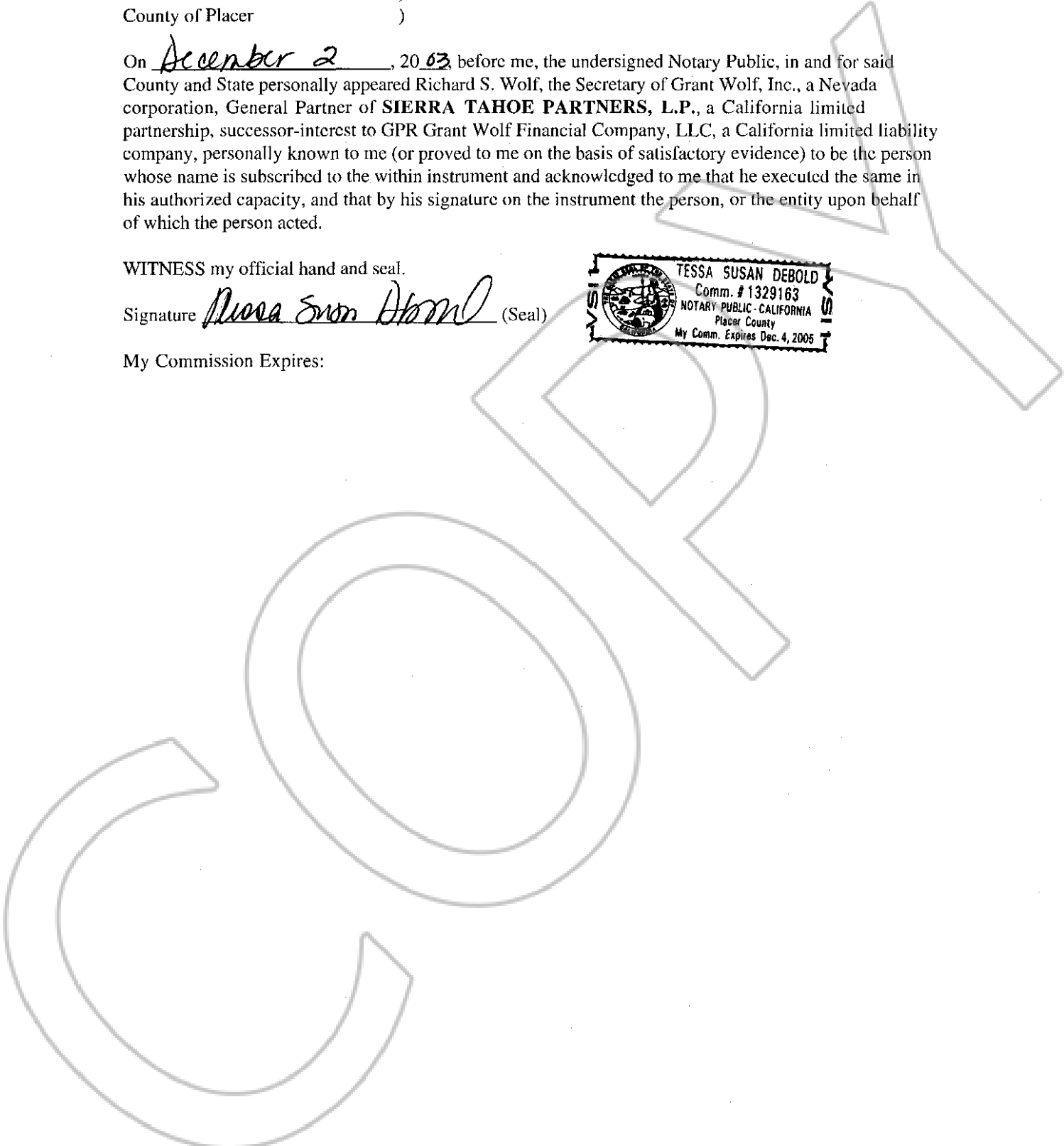
