



14 **ORDER AND JUDGMENT CONFIRMING MASTER'S FINDINGS AND**
15 **RECOMMENDATIONS FOR SUPPORT**

16 THIS MATTER having regularly come for hearing before the Master on the 14th day
17 of November, 2003; the Petitioner/Obligee being () present (X) not present; and the
18 Respondent/ Obligor being duly served and () present (X) not present, and represented
19 by _____ and Evan Peavers of the Douglas County District Attorney's
20 Office appearing and representing the State of Nevada's interest in the support and welfare
21 of the child(ren) pursuant to law. After hearing all of the evidence and being fully advised
22 in the premises, the Master makes the following findings and recommendations:

23 **FINDINGS OF FACT AND CONCLUSIONS OF LAW**

24 1. (X) The Court has jurisdiction of the parties and of the subject matter of this
25 case.

26 2. (X) The Respondent/Obligor is the parent of:

27 ALLISON M. SALTER; born: March 29, 1990.

1 3. The Respondent/Obligor owes support arrears to the Petitioner/Obligee
2 in the amount of \$ 3,355⁰⁰ from 4/94 through 10/03.

3 **IT IS HEREBY RECOMMENDED THAT:**

4 1. A judgment of support arrears is entered in favor of the
5 Petitioner/Obligee and against the Respondent/Obligor in the amount of \$ 3,355⁰⁰,
6 from 4/94 through 10/03, and the Respondent/Obligor is to pay
7 \$ 180⁰⁰ per month beginning November, 2003, and also continuing each and
8 every month thereafter until paid in full.

9 **OTHER RECOMMENDATIONS REGARDING PAYMENT:** In the event the
10 payments are not made in full by wage withholding or Defendant becomes
11 unemployed or underemployed, all child support payments must be made in the
12 form of a cashier's check, certified check, money order, or in cash. If the payment
13 is in the form of cash, it must be delivered to the Douglas County Clerk at her office
14 in the Old Minden Inn located at 1594 Esmeralda Avenue, Suite 105, Minden,
15 Nevada. If the payment is in the form of a cashier's check, certified check, or money
16 order, it must be made payable to the **STATE COLLECTIONS AND**
17 **DISBURSEMENT UNIT (SCaDU)**, with the notation **Case No.563412307A**, and it
18 must be mailed to the STATE COLLECTIONS AND DISBURSEMENT UNIT
19 (SCaDU), P.O. BOX 98950, LAS VEGAS, NV 89193-8950.

20 2. The Respondent/Obligor shall notify the Douglas County District
21 Attorney's Office, Child Support Division, at 782-9881, of any changes of address,
22 employment or change in the availability of health insurance coverage within ten (10) days
23 of such change.

24 3. **THIS IS AN INCOME WITHHOLDING ORDER.** A mandatory wage
25 withholding shall be initiated against the Respondent/Obligor's wages or commissions.
26 This does not preclude the use of other means to collect any arrears or enforce this order,
27 including garnishment, liens, attachments, execution on real or personal property or
28 interception of Federal Income Tax refunds.
