DAWSON REVOCABLE TRUST Dated August 25, 1999 as to an undivided \$25,000.00 interest and DONALD JAMES TYLER, Trustee U/T/A DATED DECEMBER 8, 1992 DONALD JAMES TYLER 1992 FAMILY TRUST AGREEMENT as to an undivided \$10,000.00 and JEAN IRIBARREN and GRACE IRIBARREN, Trustee of THE IRIBARREN FAMILY LIVING TRUST, Dated April 29, 1996 as to an undivided \$60,000.00 interest and JOHN SCOTT and MARLEANE SCOTT , husband and wife as Joint Tenants as to an undivided \$29,000.00 interest

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada, in the book and at the page thereof, or under the document file number, noted below opposite the name of such county, namely:
