ORDER FOR NOTICE TO SET; ORDER REDUCING A PORTION OF ALIMONY ARREARS TO JUDGMENT; ORDER REQUIRING PLAINTIFF TO FILE ADDITIONAL DOCUMENTATION

Having reviewed John F. Sieben's (Mr. Sieben) Motion to Modify Alimony, Deborah A. Sieben's (Ms. Sieben) Response to Plaintiff's Motion to Modify Alimony, and all related papers in the file, the Court finds and orders as follows.

Motion for Modification of Alimony

Taking all the allegations in Mr. Sieben's Motion as true, the Court finds Mr. Sieben has set forth a prima facie case of changed circumstances warranting a hearing regarding his request for modification of his alimony obligation. Specifically, the Court finds the parties' Decree of Divorce, issued February 4, 1997, specifically allows Mr. Sieben to seek a modification or termination of his alimony obligation if Ms. Sieben receives a substantial monetary award from a judgment in the case of General Builders, Inc. vs. Great American Insurance Company. (Decree, p.9) Ms. Sieben acknowledges she received \$131,450.00 in

1997 as her share of the settlement of the lawsuit, but claims the funds are earmarked for retirement and do not place her in an situation where she can live off her investment earnings at this time.

The Court concludes the 1997 settlement proceeds as well as allegations that Mr. Sieben is no longer financially capable of paying the amount ordered under the Decree and Ms. Sieben's current financial situation constitute changed circumstances warranting a hearing. At the hearing, the Court will determine what if any effect these changes have had on the parties and whether the changes warrant a modification of Mr. Sieben's alimony obligation.

Within fifteen (15) days of the date of this Order, Mr. Sieben shall send a Notice to Set (form F-1, available at the Washoe County Clerk's Office), selecting a Tuesday, Wednesday, or Thursday between the hours of 9:00 a.m. and 12:00 p.m., to Ms. Sieben's attorney of record to appear before Department Two of the Second Judicial District Court, to set a hearing regarding modification of alimony.

Alimony Arrears

The Court finds Mr. Sieben has a substantial alimony arrearage. Having received no written objection to Ms. Sieben's schedule of arrears, filed May 8, 2003, the Court reduces Mr. Sieben's arrears, incurred through February 2003, to judgment in the amount of \$24,600.00 plus interest. Ms. Sieben's request to reduce arrears incurred from March 2003 forward to judgment is held in abeyance pending a final decision on Mr. Sieben's Motion to Modify Alimony, filed March 28, 2003.

Financial Documentation

Within fifteen (15) days of the date of this Order, Mr. Sieben to file an updated financial declaration and a copy of his 2003 individual and business Federal Income tax returns.


