### SPECIAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, **MATHILDA F. MINOR**  
have made, constituted, and appointed, and by these presents do make, constitute and appoint

as my true and lawful attorney for and in my name, place and stead, and for my use and

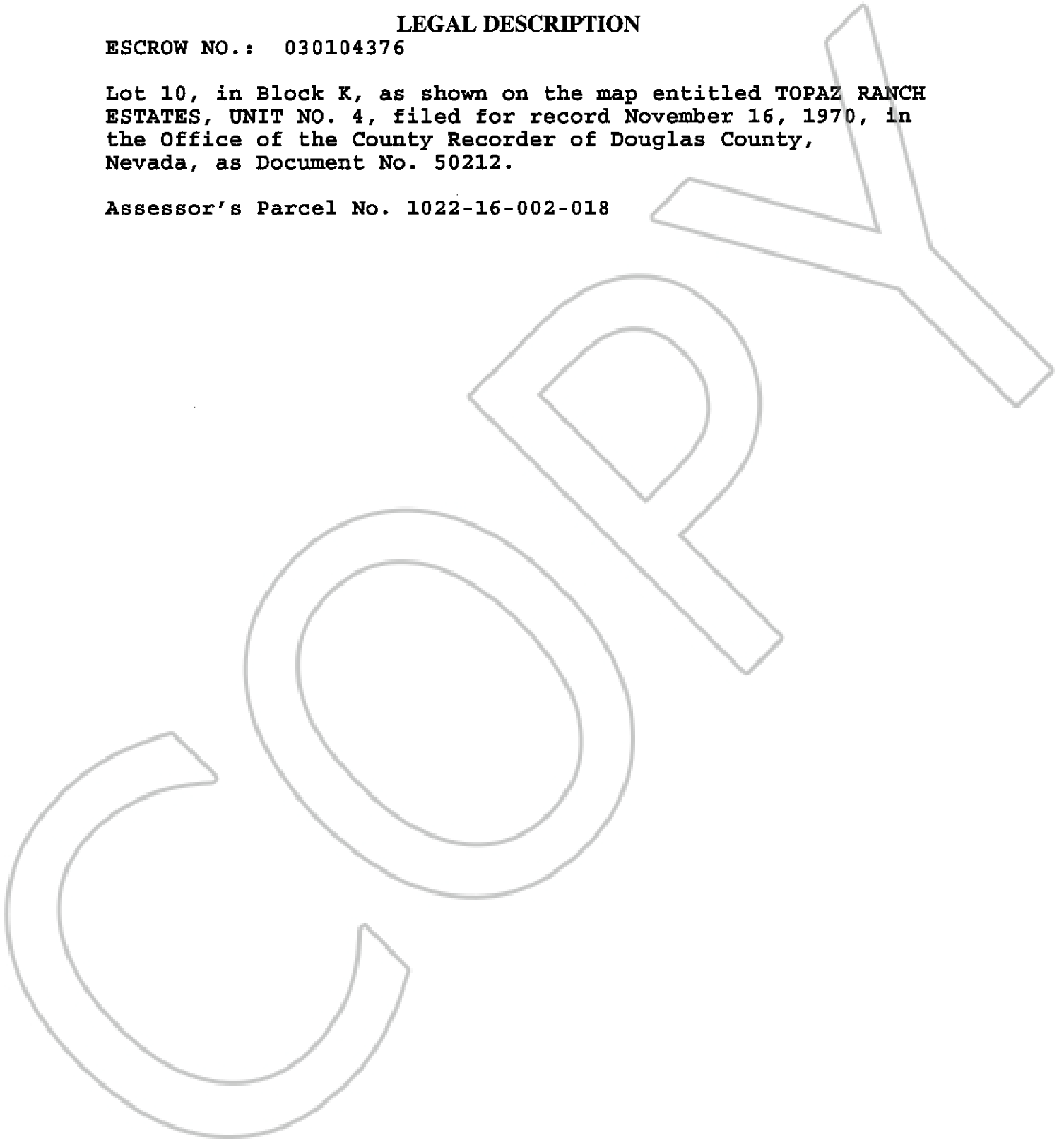
