**Deed of Full Reconveyance**

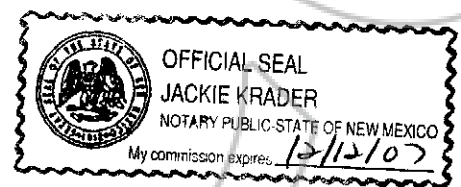
