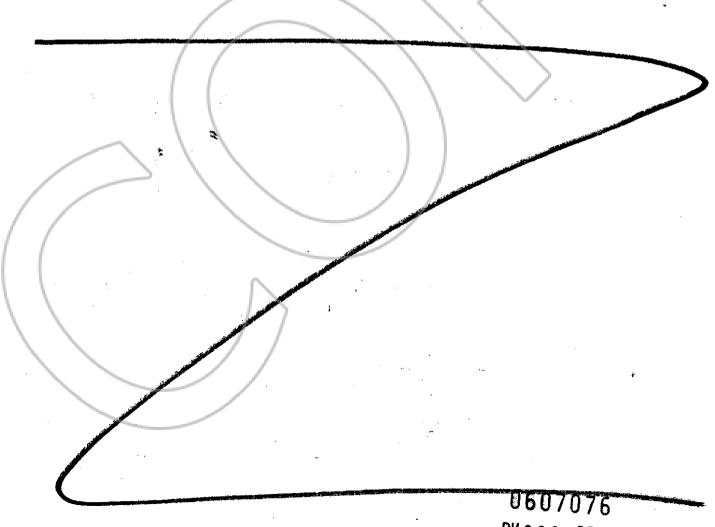
## Legal Description
