## PARTIAL RECONVEYANCE


### KNOW ALL MEN BY THESE PRESENTS:

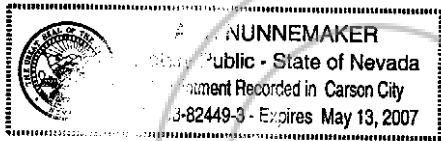
