SEVENTH AMENDMENT TO AN INTERLOCAL CONTRACTOR APR -6 AM 10: 07

BETWEEN DOUGLAS COUNTY,
THE TAHOE-DOUGLAS TRANSPORTATION DISTRICT
AND THE TAHOE TRANSPORTATION DISTRICT

This seventh amendment of a previously approved inter-local contract is made by and between Douglas County (County), the Tahoe-Douglas Transportation District (TDTD), and the Tahoe Transportation District (TTD).

AMENDMENT

1. Paragraph 1 of the interlocal contract is amended to read as follows:

This interlocal contract was originally approved by the TTD on February 13, 1998, and by the Douglas County Board of Commissioners on February 19, 1998. The second through the sixth amendments extended the contract time one year at a time, through December 31, 2003. This seventh amendment extends the contract time through December 31, 2004, unless terminated sooner in accordance with ¶ 3 or unless extended by the written agreement of the parties.

- 2. County will pay to the TTD the cost of transit services provided by Area Transit Management during the calendar year 2004, plus \$200 per month for ten months for contract administration by the TTD, for a total estimated cost to the County of \$131,465.20. Funding for the contract has been established through the County's 5-Year Transportation Plan.
- 3. All other terms of the interlocal agreement remain unchanged and in effect.
