

ORDER AFTER HEARING TO SHOW CAUSE

13 Johnny C. Bolin,
14 Defendant.

15 This matter came before the court October 28, 2003, upon
16 application by the Douglas County District Attorney's Child Support
17 Enforcement Office on behalf of the State of California and Michelle
18 D. Bolin to summon Johnny C. Bolin to appear and show cause why he
19 should not be held in contempt of court for failure to pay support for
20 Bobby C. Bolin, born October 8, 1982, pursuant to that certain order
21 from the Superior Court for Stanislaus County, California, dated May
22 6, 2003. The defendant, Johnny C. Bolin, was present without counsel
23 and the State of California was represented by Evan Beavers, deputy
24 district attorney for child support enforcement. Also present was
25 Kris Brown, case worker for the district attorney's office.

26 According to the application and the briefing offered by Mr.
27 Beavers, the original obligation for Mr. Bolin to support his minor
28 child was entered December 29, 1998, in Stanislaus County, California,
and the monthly support obligation was set at \$343 each month. The

1 minor child emancipated in October 2000, and during the years 2001 and
2 2002 Douglas County District Attorney's Office made various efforts,
3 without success, for the defendant to comply with repayment agreements
4 to avoid suspension of his driver's license for nonpayment of child
5 support. In May 2003 the Stanislaus County Superior Court adjudicated
6 arrears in the amount of \$3,611.22 and ordered payment on those
7 arrears at the rate of \$75 each month. According to the Application
8 for an Order to Show Cause in August 2003 the defendant had made no
9 payments on that adjudicated arrearage.

10 In his defense Mr. Bolin explained that without a driver's
11 license he could not work and that he subsisted on unemployment
12 benefits through the end of 2002 and since that time had been
13 subsisting on odd jobs for cash payment. He admitted to not having
14 any physical disability and that he had last looked for full time
15 employment a few months prior to the hearing.

16 Based upon the foregoing the court finds the defendant, Johnny
17 C. Bolin, to be willfully underemployed and in contempt of court for
18 failing to pay child support as required by the orders of the Superior
19 Court of California for Stanislaus County, and good cause appearing
20 therefore,

21 IT IS HEREBY ORDERED that the imposition of 20 days incarceration
22 for contempt of court shall be, and the same hereby is, suspended on
23 the following conditions:


- 24 1. Defendant shall pay \$100 on or before November 5, 2003, and
25 each month thereafter, toward arrears adjudicated at \$3,611.22;
- 26 2. Defendant shall secure employment with a wage identifiable
27 for the district attorney's office to effect a wage withholding for
28 the payment of child support.

1 IT IS FURTHER ORDERED that the district attorney's office, upon
2 the payment of \$300 cash, shall proceed with entering into a repayment
3 agreement for the purpose of reinstating his driving privileges.


