28 4. That affiant cannot provide the responsible parent's driver's license number.



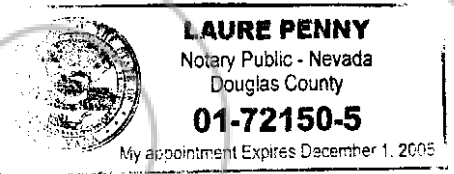

16 THIS MATTER came before the court on March 1, 2004 for a review hearing as
17 to the status of compliance by Defendant, Lawrence Robert Cripe, with the order of this
18 Court and of the order of the California Superior Court for Orange County regarding
19 payments on arrears and status of Mr. Cripe's driving privileges.. Present in court were
20 Lawrence Robert Cripe, with counsel, Alan Erb; and Evan Beavers, Deputy District
21 Attorney appearing on behalf of the district attorney's child support enforcement office,
22 along with Kris Brown, child support officer.

23 This matter came before the court originally on December 1, 2003, upon
24 application by the Douglas County District Attorney's Child Support Enforcement Office
25 on behalf of Orange County and Karen Ann Cripe for defendant Lawrence Robert Cripe
26 to appear and show cause why he should not be held in contempt for failure to pay
27 child support as ordered by the Superior Court of California, County of Orange, on
28 January 15, 2003. At that time Mr. Cripe was ordered to pay \$1,200 in one payment


1 and pay \$200 each month thereafter toward arrears of \$24,307.87. The court also
2 ordered a review hearing be scheduled for March 1, 2004 to review the status of Mr.
3 Cripe's payments and Mr. Erb's efforts to contact Orange County to reinstate Mr.
4 Cripe's California driver's license.

5 Mr. Erb briefed the court that after many unsuccessful attempts to contact
6 authorities in Orange County, no progress was made as to Mr. Cripes driver's license.
7 Mr. Erb explained that Mr. Cripe is complying with the Order of this court as to support
8 payments. Mr. Cripe provided a copy of the February 2004 payment to the District
9 Attorney Child Support Enforcement Office. Mr. Beavers agreed with Mr. Erb's
10 summary of the record


11 Based upon the foregoing and good cause appearing therefore,
12 IT IS HEREBY ORDERED that Mr. Cripe continue to pay \$200.00 per month to
13 satisfy the arrears that are currently owed, and that efforts continue for reinstatement of
14 the California license so that Mr. Cripe can secure a Nevada license and pursue
15 additional work and possibly increase his monthly payments.

16 This matter need not be placed back on the calendar of the court until, and
17 unless, the present circumstances change.
