

ORDER AFTER HEARING TO SHOW CAUSE

THIS MATTER came before the court upon the application by the Douglas County District Attorney's Child Support Enforcement Office on behalf of the State of Idaho and to summon the defendant John Paul Davis to appear and show cause why he should not be held in contempt of court for failure to obey the order of this court entered February 10, 2003, obligating the defendant to pay child support for River Lee Davis, born October 20, 1997. The defendant, John Paul Davis, failed to appear for the contempt proceeding. Evan Beavers, deputy district attorney for child support enforcement appeared for the State of Idaho, along with Kris Brown, caseworker for this case.

According to the record as presented by Mr. Beavers and the Application for a Hearing to Show Cause, Mr. Davis had originally objected to the master's recommendations which resulted in the February 2003 order, but he failed to appear at the hearing he requested on those objections. His arrears owing through July 31,

2003, the date of application for the hearing, amounted to \$5,345.35, and the defendant has failed to maintain contact with the district attorney's office and the district attorney's office has been unable to identify an employer for the defendant. The defendant has no Nevada driver's license which might be suspended to effect the defendant's compliance with his obligation for support.

Based upon the foregoing, the defendant John Paul Davis is found to be in contempt of the court for failure to pay child support as required by that order of this court entered February 10, 2003 obligating the defendant to pay \$200 each month commencing July 31, 2003, as ongoing support and an additional \$20 each month toward arrears adjudicated at that time in the amount of \$5,345.35, and the court hereby finds that the defendant's arrears for the support of River Lee Davis as of September 30, 2003, amount to \$5,745.35, and good cause appearing therefore,

IT IS HEREBY ORDERED that a bench warrant issue for the arrest of the defendant John Paul Davis for failing to appear and that upon his arrest he be held until such time as he can be brought before the court to answer as to his nonappearance and that he be released only upon the posting of a cash only bail in the amount of \$2,000.

IT IS FURTHER ORDERED that all other terms and conditions of the order of this court dated February 10, 2003, are in full force and
