

ORDER AFTER
HEARING TO SHOW CAUSE

15 THIS MATTER came before the court upon the application by the
16 Douglas County District Attorney's Child Support Enforcement Office
17 on behalf of the State of Idaho and to summon the defendant John Paul
18 Davis to appear and show cause why he should not be held in contempt
19 of court for failure to obey the order of this court entered February
20 10, 2003, obligating the defendant to pay child support for River Lee
21 Davis, born October 20, 1997. The defendant, John Paul Davis, failed
22 to appear for the contempt proceeding. Evan Beavers, deputy district
23 attorney for child support enforcement appeared for the State of
24 Idaho, along with Kris Brown, caseworker for this case.

25 According to the record as presented by Mr. Beavers and the
26 Application for a Hearing to Show Cause, Mr. Davis had originally
27 objected to the master's recommendations which resulted in the
28 February 2003 order, but he failed to appear at the hearing he
requested on those objections. His arrears owing through July 31,

1 2003, the date of application for the hearing, amounted to \$5,345.35,
2 and the defendant has failed to maintain contact with the district
3 attorney's office and the district attorney's office has been unable
4 to identify an employer for the defendant. The defendant has no
5 Nevada driver's license which might be suspended to effect the
6 defendant's compliance with his obligation for support.

7 Based upon the foregoing, the defendant John Paul Davis is found
8 to be in contempt of the court for failure to pay child support as
9 required by that order of this court entered February 10, 2003
10 obligating the defendant to pay \$200 each month commencing July 31,
11 2003, as ongoing support and an additional \$20 each month toward
12 arrears adjudicated at that time in the amount of \$5,345.35, and the
13 court hereby finds that the defendant's arrears for the support of
14 River Lee Davis as of September 30, 2003, amount to \$5,745.35, and
15 good cause appearing therefore,

16 IT IS HEREBY ORDERED that a bench warrant issue for the arrest
17 of the defendant John Paul Davis for failing to appear and that upon
18 his arrest he be held until such time as he can be brought before the
19 court to answer as to his nonappearance and that he be released only
20 upon the posting of a cash only bail in the amount of \$2,000.

21 IT IS FURTHER ORDERED that all other terms and conditions of the
22 order of this court dated February 10, 2003, are in full force and
