FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF JEWEL COMMERCIAL PARK (PHASE I)

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF JEWEL COMMERCIAL PARK (PHASE I) is made and entered into this _______ day of _________, 2004, by the undersigned owners and members of JEWEL COMMERCIAL PARK.

WHEREAS, on September 2, 1992, a Declaration of Covenants, Conditions and Restrictions of JEWEL COMMERCIAL PARK (PHASE I) ("Declaration") was created which established certain covenants, conditions and restrictions on lands therein referred to as JEWEL COMMERCIAL PARK or "Project."

WHEREAS, the Declaration contemplated an Association to govern the development of lands located within Project through the enforcement of the covenants, conditions and restrictions and all the rules, regulations and bylaws contemplated in the Declaration.

WHEREAS, the undersigned, as the owners of title to a majority of the lots and at least three-quarters (3/4) of the land burdened by the Declaration, now desire to amend the Declaration in accordance with the terms of the Declaration.

whereas, the undersigned desire to specify that the voting rights afforded the owners and members of the Association be specifically linked to the amount of land that the respective owner or member owns in proportion to the total amount of land governed by all the owners or members subject to the Declaration.

WITNESSETH:

NOW, THEREFORE, in furtherance of such intent, the undersigned hereby declare as follows:

- 1. In accordance with Declaration Section 3.12, the undersigned, constituting a majority of all the Owners as defined in the Declaration, hereby amend Section 3.03(E) to read as follows:
 - (E) Voting Rights and Proxy: Only Members of the Association shall be entitled to vote. The votes allocated to each Member shall be allocated in proportion to the area that such Member owns in relation to the total area of all the area owned by Members governed by the

Declaration. Any Member, including Declarant, may give a revocable written proxy to any person authorizing the latter to cast the Member's votes on any matter. Any section within this Declaration that is inconsistent with this Section 3.03(E) shall be deemed void to the extent that it is inconsistent with this section.
