Deed of Full Reconveyance

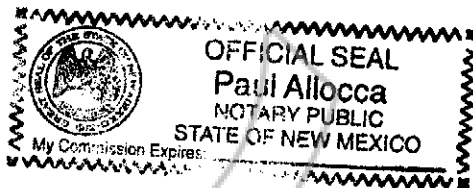
