25 IT IS ORDERED:

26 1. That Cross-Complainant, POTTYPAL, LLC, a Nevada limited
27 liability company shall have judgment against Cross-Defendant, WEBQUEST
28 INTERNATIONAL, INC., in the principal sum of \$75,000.00.

1 2. Interest is awarded on the judgment from the date entered
2 until the judgment is satisfied in full at the rate allowed by NRS
3 17.130.

5 INTERNATIONAL, INC. for the additional sum of \$40,304.21 as and for
