WILSON TRUSTEE, OF THE VICTOR L. WILSON TRUST MARCH 18, 1980, BENEFICIARY**,

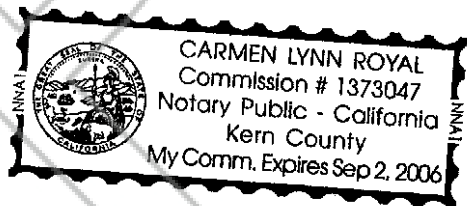

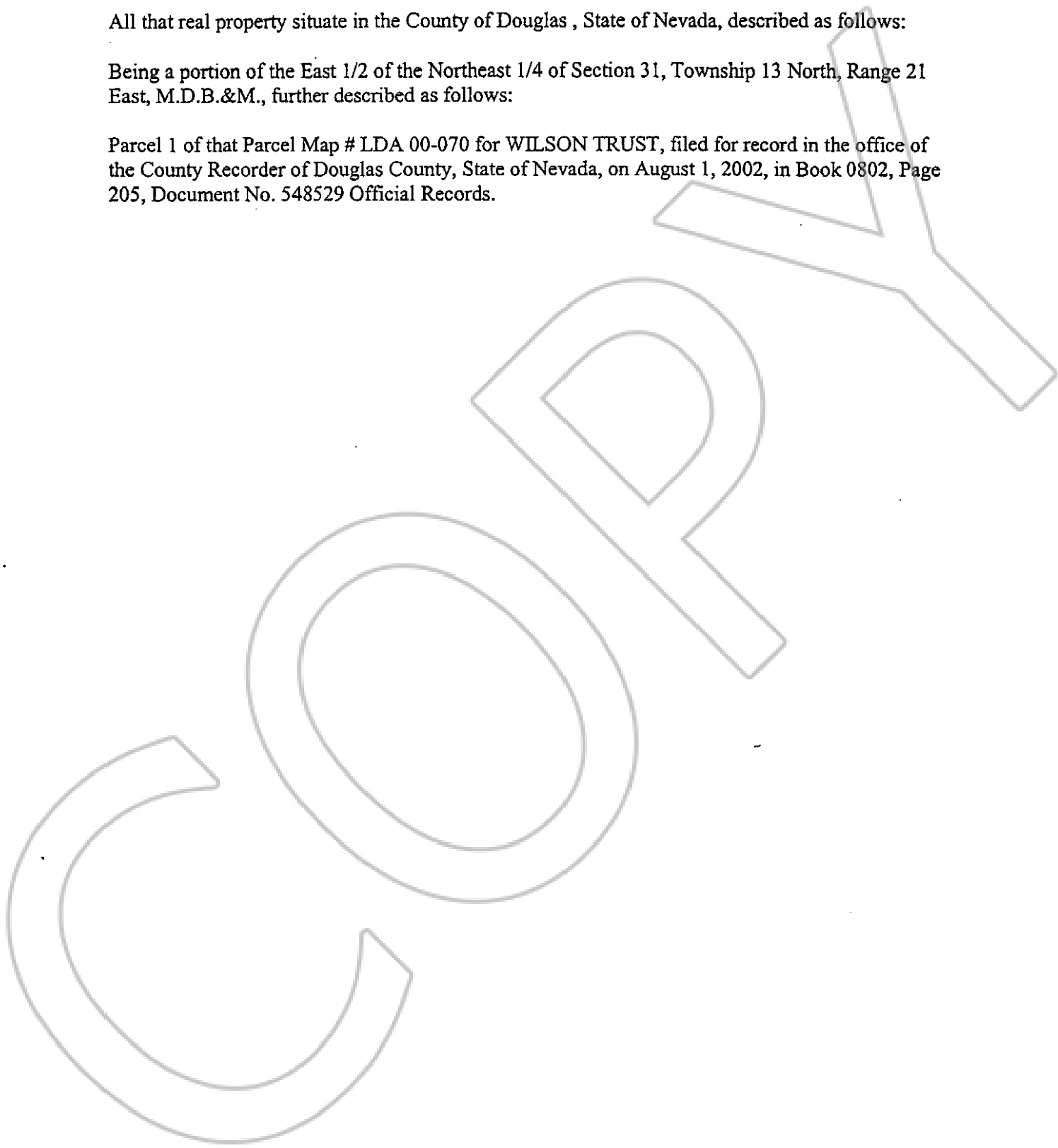
