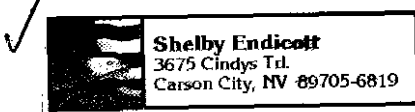

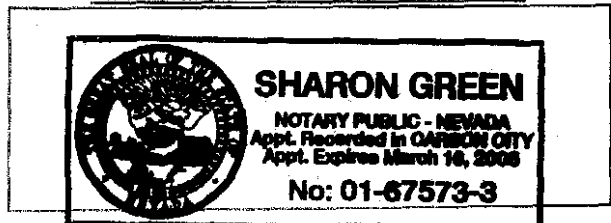

LEGAL DESCRIPTION

The land referred to herein is situated in the State of Nevada, County of DOUGLAS, described as follows:

COMMENCING at a found brass cap marking the Section corner common to Section 1, 6, 7 and 12 in Township 14 North, Range 19 East, and 14 North, Range 20 East; thence along the East line of said Section 1, North $0^{\circ}05'45''$ West a distance of 2,642.16 feet; thence South $89^{\circ}23'30''$ West a distance of 744.23 feet to the True Point of Beginning; thence from the True Point of Beginning, South $0^{\circ}05'45''$ East a distance of 176.00 feet, thence South $89^{\circ}23'30''$ West a distance of 226.87 feet; thence North $0^{\circ}05'45''$ West a distance of 176.00 feet, thence North $89^{\circ}23'30''$ East a distance of 226.87 feet to the True Point of Beginning.
