## LIMITED POWER OF ATTORNEY

I, **Robert Bruce MacCleod**, currently residing in Mitchell, South Dakota, appoint my mother, Millie E. MacCleod currently residing in the city of Plant City, state of Florida; whose home phone number is: 813-659-2953, as my Attorney-in-Fact, with full power to carry out those acts specified in this Limited Power of Attorney.

I confer the following powers upon my Attorney-in-Fact with respect to my assets, real, personal or mixed, standing in my name, held for my benefit or acquired for my benefit:


1. As to any commercial checking, savings, money market, treasury bills, mutual fund accounts, safe deposit boxes, in my name or opened for my benefit - to open, withdraw, deposit into, close, and to negotiate, endorse, or transfer any instrument affecting those accounts;

4. As to any real property, to collect rents, disburse funds, keep in repair, hire professional property managers, lease to tenants, negotiate and renegotiate leases, borrow against, renew any loan, sign any documents required for any such transaction, and to sell, any of the real property;
5. To hire and pay from my funds for counsel and services of professional advisors, physicians, dentists, accountants, attorneys and investment counselors;
6. As to my income taxes and other taxes - to sign my name, hire preparers and advisors and pay for their services;
7. To apply for government and insurance benefits, to prosecute and to defend legal actions and to arrange for transportation and travel;
8. To manage tangible personal property, including but not limited to, moving, storing, selling, donating, or otherwise disposing of said property;

No person who in good faith relies upon any representation by my Agent shall be liable to me, my estate, my heirs or assigns, for recognizing the agent's authority. This power of attorney is intended to be valid in any jurisdiction in which it is presented. The powers delegated under

this power of attorney are separable, so that the invalidity of one or more powers shall not affect any others.

This limited power of attorney shall become valid on the Date it is signed, attested and executed by myself, and shall remain in effect until expressly revoked by myself or my Attorney-in-Fact.
