20 otherwise defend as to the Verified Complaint of Plaintiff, it appearing that said Defendant is not in the
21 military service of the United States, and is not an infant or incompetent person, and that Plaintiff has duly
22 filed a memorandum of costs incurred herein, and good cause appearing,

23 IT IS HEREBY ORDERED, ADJUDGED AND DECREED, that the said Plaintiff shall have and
24 recover from the said Defendant PHIL CLENNELL, the sum of Nine Thousand Five Hundred Forty-seven
25 and 75/100 Dollars (\$9,547.75) with interest thereon at eighteen percent (18%) per annum from the date of
26 October 22, 2003.

27 IT IS FURTHER ORDERED that Plaintiff is awarded and shall recover from Defendant PHIL
28 CLENNELL, Plaintiff's costs incurred in this action in the sum of Two Hundred Three Dollars & 65/100


