DONALD JAMES TYLER, Trustee U/T/A DATED DECEMBER 8, 1992 DONALD JAMES TYLER 1992 FAMILY TRUST AGREEMENT as to an undivided **\$30,000.00** interest DAVID TYLER, an unmarried man as to an undivided **\$4,000.00** interest and HERBERT RUPPEL and EDELTRAUT RUPPEL, Co-Trustees of THE RUPPEL FAMILY TRUST DATED OCTOBER 15, 1997 as to an undivided **\$29,000.00** interest and ROY WEST and ERNESTINE WEST, Co- Trustees of THE ROY WEST AND ERNESTINE WEST FAMILY TRUST DATED JUNE 2, 1990as to an undivided **\$36,000.00** interest and JOHN WITTRIG, an unmarried man as to an undivided **\$14,500.00** all as tenants in common ,

herein called BENEFICIARY.

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in Douglas , State of Nevada, being Assessment Parcel No. **1420-07-717-021**, more specifically described as follows:

Lot 5, Block C, as shown on the filed Map of HIGHLAND ESTATES UNIT NO. 3, filed in the office of the County Recorder of Douglas County, State of Nevada, on May 2, 1978, as Document No. 20213.

ACCELERATION CLAUSE:

In the event Trustors sell, convey or alienate the property described in this Deed of Trust securing Note, or contracts to sell, convey or alienate; or is divested of title or interest in any other manner, whether voluntarily or involuntarily without written approval of Beneficiary being first obtained, said Beneficiary shall have the right to declare the entire unpaid principal balance due and payable in full, upon written demand and notice, irrespective of the maturity date expressed in Note.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada, in the book and at the page thereof, or under the document file number, noted below opposite the name of such county, namely:


