This Real Estate Subordination Agreement ("Agreement") is executed as of <u>07/28/2004</u>, by <u>Bank of America</u>, N.A., formerly known as NationsBank, N.A. ("Bank of America"), having an address of <u>P.O. Box 26865 Richmond</u>, <u>VA 23261-7025</u> ("Subordinator"), in favor of <u>CHARLES SCHWAB BANK</u>, NA, having an address for notice purposes of \_\_, (Junior Lienholder).

Whereas, Junior Lienholder has been requested to make a loan, line of credit or other financial accommodation to <a href="MARKABCARLISLE">BARBARA B CARLISLE AND MARK F CARLISLE</a>, REVOCABLE TRUST (jointly and severally, "Borrower"), to be secured by, without limitation, either a deed of trust, deed to secure debt or mortgage (the "Junior Lien"), covering, without limitation, the Property and securing the indebtedness described therein including the payment of a promissory note, line of credit agreement or other borrowing agreement made by Borrower and/or others payable to the order of <a href="CHARLES SCHWAB BANK">CHARLES SCHWAB BANK</a>, NA in the maximum principal face amount of \$296,001.00 (the "Principal Amount"), including provisions for acceleration and payment of collection costs (the "Obligation"); and


Whereas, Junior Lienholder requires, as a condition to the making of the Obligation, that the Junior Lien be superior to the Senior Lien:

Now, Therefore, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and with the understanding by Bank of America that Junior Lienholder will rely hereon in making the Obligation, Bank of America agrees and covenants that the Senior Lien and the rights of Bank of America thereunder and all other rights of Bank of America now or hereafter existing in or with respect to the Property are hereby subordinated, and are and shall remain completely and unconditionally subordinate to the Junior Lien and the rights of Junior Lienholder thereunder regardless of the frequency or manner of renewal, extension, consolidation or modification of the Junior Lien and /or the Obligation.

This Subordination Agreement is limited to an amount of \$296,001.00, which is the original amount of the Junior Lienholder's principal balance; plus interest and any additional amounts advanced pursuant to the provision of said security instrument for payment of insurance premiums, taxes, cost of collection or protection of the value of the Property or Junior Lienholder's rights in the Property. This Agreement shall inure to the benefit of Junior Lienholder and be binding upon Bank of America, its successors and assigns and shall be binding upon any purchaser or purchasers (at foreclosure or otherwise) of the Property or any part thereof, and their respective heirs, personal representatives, successors and assigns.
