## SPECIAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, **ADRIENNE H. BRIDGES** have made, constituted, and appointed, and by these presents do make, constitute and appoint **DONALD R. BRIDGES, JR.**

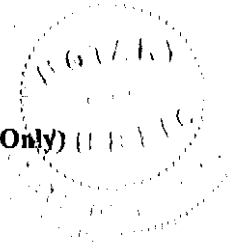

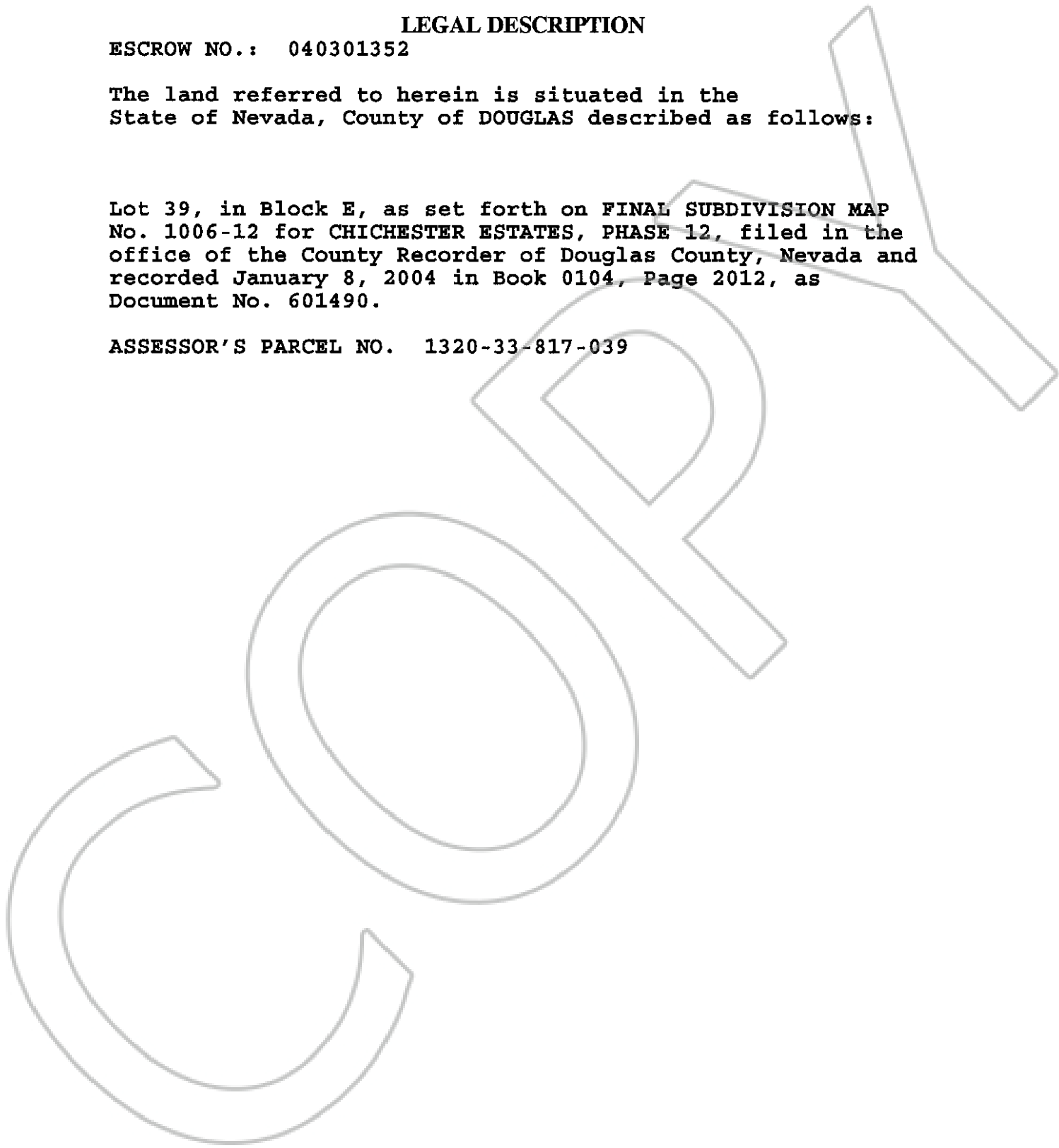
