time, and which Declaration is incorporated herein by this reference as if the same were fully set forth herein;

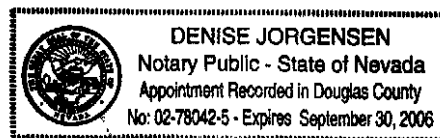
