**WITHDRAWAL AMENDMENT
TO
DECLARATION OF COVENANTS, CONDITIONS,
EASEMENTS AND RESTRICTIONS
FOR THE
RESIDENCE CLUB AT SOUTH SHORE**

This Withdrawal Amendment to Declaration of Covenants, Conditions, Easements and Restrictions for the Residence Club at South Shore ("Withdrawal Amendment") is made and executed by TRENDWEST RESORTS, INC., an Oregon corporation ("Developer") pursuant to the provisions of that certain Residence Club Declaration described in Recital A below.

RECITALS

A. Developer owns certain Units in South Shore, a condominium project ("Project") located at 180 Elks Point Road, Zephyr Cove, Douglas County, Nevada created by the recordation of that certain Declaration of Condominium – South Shore recorded in the Official Records of Douglas County, as the same is amended from time to time ("Condominium Declaration"). On December 5 2002, Developer recorded that certain Declaration of Covenants, Conditions, Easements and Restrictions for the Residence Club at South Shore as Document No. 0559874 Book 1202, Page 2217 in the Official Records of Douglas County, State of Nevada ("Residence Club Declaration") whereby Developer created a fractional ownership program under the Vacation Ownership Act referred to as the "Residence Club" in each of the Residence Club Units described in Exhibit "C," attached hereto and incorporated herein by this reference ("Residence Club Units").

B. Section 9.5 of the Residence Club Declaration provides that Developer shall have the absolute right and option, from time to time and at any time subject to the provisions of the Residence Club Declaration, to unilaterally withdraw a Residence Club Unit from the Residence Club by executing and recording in the Office of the Douglas County Recorder a unilateral

Amendment to the Residence Club Declaration (without requiring the consent of any Mortgagee, the Condominium Executive Board, the Residence Club Board or the Owners of other Units, Residence Club Units or Fractional Interests).

C. Developer desires to exercise its unilateral right to withdraw those certain thirty-seven (37) Residence Club Units from the Residence Club located within the Project as more particularly described in Exhibit "D," attached hereto and incorporated herein by this reference (the "Withdrawable Units").

D. Developer is the fee and equitable Owner of the Withdrawable Units.

E. Accordingly, pursuant to Section 9.5 of the Residence Club Declaration, Developer hereby exercises its unilateral right to execute and record this Withdrawal Amendment for the purpose of withdrawing the Withdrawable Units from the Residence Club and releasing such Withdrawable Units and the Furnishings located therein from the terms and provisions of the Vacation Ownership Act and the covenants, conditions, restrictions, uses, limitations and obligations set forth in the Residence Club Declaration.

NOW, THEREFORE, Developer hereby unilaterally exercises its right to record this Withdrawal Amendment to withdraw the Withdrawable Units from the Residence Club as follows:

1. Defined Terms and Status of the Recitals. Capitalized terms used and not otherwise defined in this Withdrawal Amendment shall have the meaning or meanings given to them in the Residence Club Declaration. The Recitals set forth above shall constitute a portion of the terms of this Withdrawal Amendment.

2. Withdrawal of Withdrawable Units. The Withdrawable Units are hereby withdrawn from the Residence Club pursuant to the provisions of Section 9.5 of the Residence Club Declaration and are described on Exhibit "D" attached hereto and incorporated herein by this reference. The Withdrawable Units may be held, transferred, sold, conveyed and occupied pursuant to the terms and provisions of the Condominium Declaration. However, from and after of the date set forth below, the Withdrawable Units are hereby forever released from the provisions of the Vacation Ownership Act and the covenants, restrictions, easements, charges and liens of the Residence Club Declaration, and are no longer submitted to, nor governed by, the provisions of the Residence Club Declaration, or any amendments or supplements thereto, and are hereby removed from the jurisdiction of the Residence Club Association, unless Developer determines otherwise in its sole and exclusive discretion pursuant to its recordation of a subsequent Amendment to the Residence Club Declaration. Moreover, from and after the date set forth below, Developer is the sole Owner and holder of both legal and equitable fee simple title to the Withdrawable Units, and none of the Residence Club Owners or any other third persons have any claim or title to or interest in such Withdrawable Units.

3. Reallocation of Fractional Allocations and Replacement of the Scheduled Set Forth in Exhibit A. Pursuant to Section 9.5 of the Residence Club Declaration, the Fractional

Allocations for the remaining Fractional Interests are hereby reallocated on the same basis as described in Section 6.2 of the Condominium Declaration and Section 3.2 of this Residence Club Declaration. Exhibit "A" to the Residence Club Declaration, setting forth the legal description of the Residence Club and the Schedule of Residence Club Units, Unit Types, Actual Square Footage, Average Square Footage, Votes and Fractional Allocations, is hereby amended and restated in its entirety by Exhibit "A" attached to this Withdrawal Amendment and incorporated herein by this reference. Fractional Allocations and votes of all remaining Fractional Interests shall be as set forth in Exhibit A. The Occupancy Schedule for the Residence Club Units is hereby amended and restated in its entirety by Exhibit "B", which is attached to this Withdrawal Amendment and incorporated herein by this reference.

4. Residence Club Declaration and Condominium Declaration Remain in Effect. This Withdrawal Amendment shall be considered an Amendment to the Residence Club Declaration. Except as expressly amended by the foregoing, the Residence Club Declaration shall remain in full force and effect and shall not be cancelled, suspended or otherwise abrogated against the remaining twenty-two (22) Residence Club Units in the Residence Club by the recording of this Withdrawal Amendment. This Withdrawal Amendment does not constitute an amendment to the Condominium Declaration and the Condominium Declaration shall remain in full force and effect and shall not be cancelled, suspended or otherwise abrogated against the Withdrawable Units or the remaining twenty-two (22) Residence Club Units in the Residence Club by the recording of this Withdrawal Amendment.

5. Reservation of Developer Rights. Pursuant to the Vacation Ownership Act and the Residence Club Declaration, all Developer rights concerning the Residence Club reserved to Developer in the Residence Club Declaration are hereby reaffirmed and reserved with respect to the twenty-two (22) Residence Club Units remaining in the Residence Club. The exercise of Developer Rights concerning such remaining Residence Club Units shall be governed by the same terms, provisions and limitations set forth in the Residence Club Declaration regarding the exercise of such Developer Rights.

6. Authority. Developer hereby certifies that Developer may execute this Withdrawal Amendment without the consent or signature of any Mortgagee, the Condominium Executive Board, the Residence Club Board or the Owners of other Units, Residence Club Units or Fractional Interests as provided in Section 9.5 of the Residence Club Declaration.

7. No Further Amendments Intended. This Withdrawal Amendment shall be considered supplemental to the Residence Club Declaration and except as expressly amended by the foregoing, the Residence Club Declaration shall remain in full force and effect and shall not be canceled, suspended or otherwise abrogated by the recording of this Withdrawal Amendment.

8. Effective Date. This Withdrawal Amendment shall take effect when recorded in the Office of the County Recorder for Douglas County, Nevada.




