SUBSTITUTION OF TRUSTEE and FULL RECONVEYANCE

AND WHEREAS said Note, together with all the other indebtedness secured by said Deed of Trust, has been fully paid and satisfied, NowLine is hereby requested and directed upon surrender to it of said Note, Deed of Trust, and evidence of any other indebtedness secured thereby, for cancellation and retention, and upon payment to you of any sums owing to you under the terms of said Deed of Trust, to reconvey, without warranty, to the parties designated by the terms of said Deed of Trust, all the estate now held by the Successor Trustee. NowLine, as successor trustee under the hereinabove described deed of trust, hereby reconveys, without warranty, to the person legally entitled thereto, the trust property now held by it as Trustee under said Deed of Trust.

IN WITNESS WHEREOF, the said NowLine has caused this instrument to be executed in its name on this 6TH day of AUGUST, 2004.

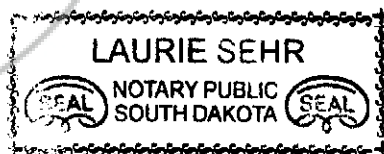
