SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 3rd day of September, 2004, between , KRISTINE McEWEN , an unmarried woman , herein called TRUSTOR,

and **MARQUIS TITLE & ESCROW, INC.,** a Nevada Corporation, herein called TRUSTEE and

GEORGE JAMES BEARD and CHRISTINE MARIE BEARD , husband and wife as joint tenants , herein called BENEFICIARY.

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in Douglas , State of Nevada, being Assessment Parcel No. **1121-05-512-009**, more specifically described as follows:

A Leasehold estate as created by that certain lease dated July 2, 2002, made by and between JOHNSON DEVELOPMENT, LLC, a Nevada Limited Liability Company, as lessor and a Nevada Limited Liability Company, KRISTINE McEWEN, an unmarried woman, as lessee, for the term and upon the terms and conditions contained in said lease recorded November 18, 2002, in Book 0202, Page 7290, as Document No. 558103, of Official Records.

ACCELERATION CLAUSE:

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada, in the book and at the page thereof, or under the document file number, noted below opposite the name of such county, namely:
