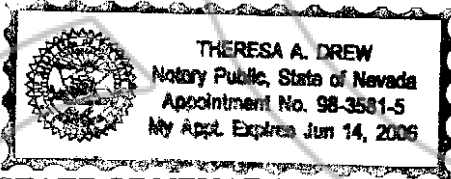
THAT the name of the record owner thereof is ANTHONY D. TATE and LENORA M. TATE, husband and wife as joint tenants with right of survivorship.
