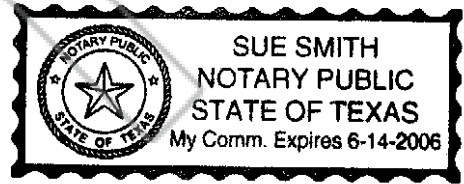

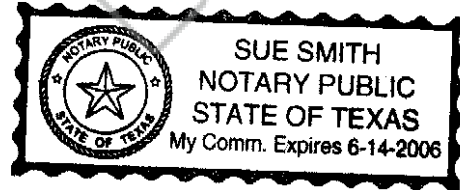

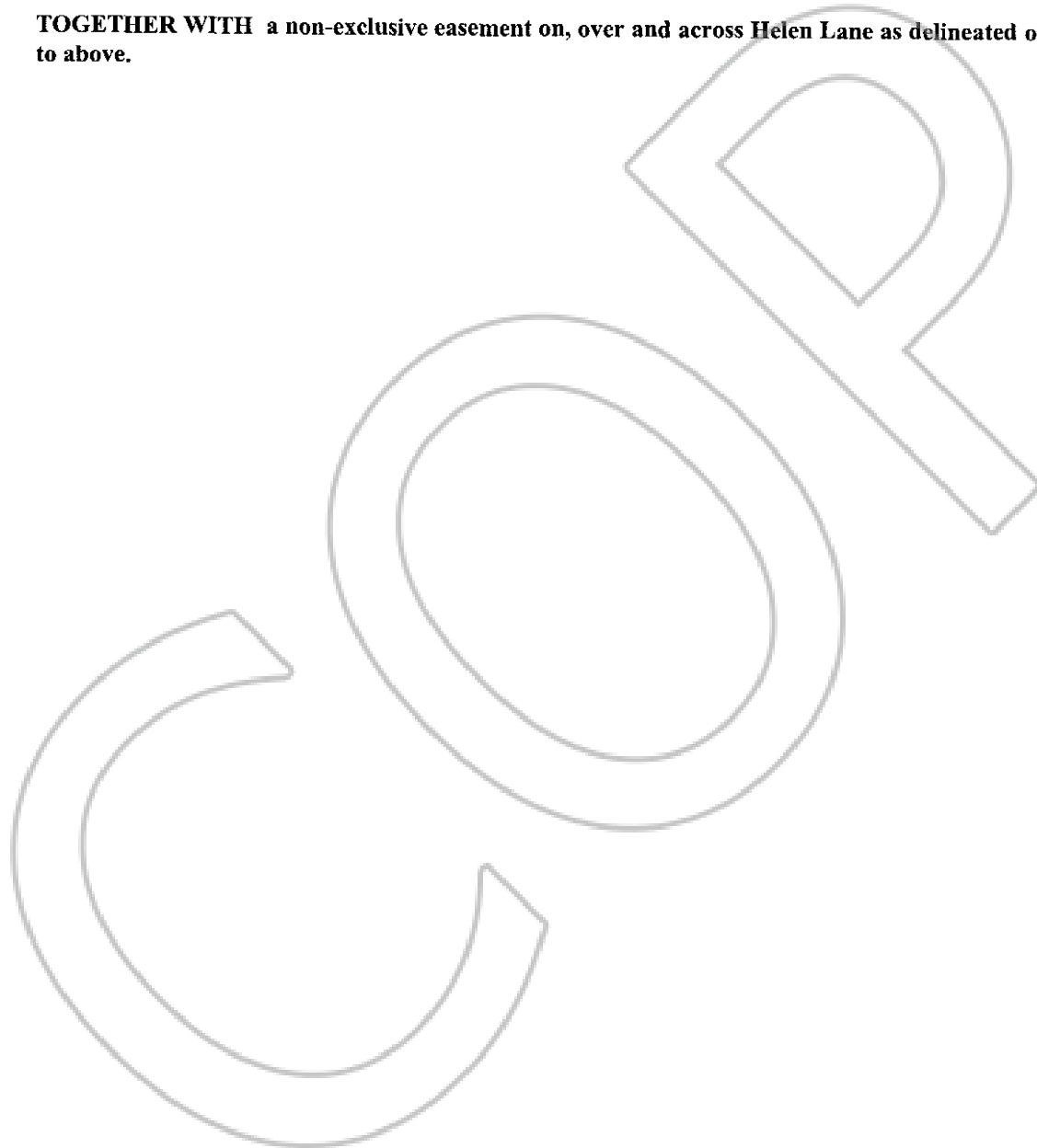
Exhibit A
