## IRREVOCABLE POWER-OF-ATTORNEY REGARDING TRANSFER OF LAND COVERAGE

This Irrevocable Power-of-attorney Regarding Transfer of Hard Land Coverage ("Power-of-Attorney") is made as of the 1<sup>st</sup> day of September 2004 ("Effective Date"), by and between FALCON CAPITAL, LLC, a Wyoming limited liability company ("Seller") and ANATOLI STEIN, an individual ("Purchaser").

WHEREAS, appurtenant to the Sending Parcel are one thousand seven hundred one (1,701) square feet of Class 1b land coverage in Hydrological Zone 4 (the "Coverage"), as defined in the Tahoe Regional Planning Agency ("TRPA") Code of Ordinances ("Code").

WHEREAS, Seller has conveyed the Coverage to Purchaser pursuant to that certain Agreement for Purchase and Sale of Land Coverage dated of even date herewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Seller hereby appoints Purchaser, its members or appointees, as agent ("Agent") solely for the limited purposes of transferring all or any portion of the Coverage (1,701 square feet of Class 1b land coverage located in Hydrological Zone 4 on the Property) to an appropriate receiving parcel(s) designated by Purchaser and approved by TRPA. Agent is authorized and empowered to execute on behalf of Seller, from time to time, (i) all declarations of covenants, conditions, and restrictions pertaining to the Coverage in the form required by TRPA and approved by both TRPA and Seller, and (ii) TRPA applications and other documents reasonably required by TRPA to transfer the Coverage from the Sending Parcel to appropriate receiving parcel(s) designated by Purchaser and approved by TRPA.

Seller and Purchaser have agreed the Coverage may remain banked on the Sending Parcel until transferred to receiving parcel(s) designated by Purchaser and approved by TRPA. Seller has agreed, among other things, not to encumber the Coverage in any manner (except in favor of
