THIS INDENTURE WITNESSETH: That **GILBERT F. CALDWELL** and **JANE C. CALDWELL**, husband and wife

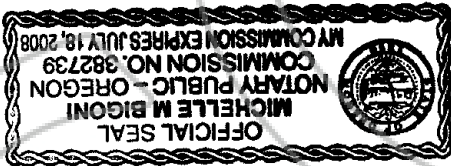
