13 This matter having come before the Court pursuant to the stipulation between
14 the parties filed with the Court on September 30, 2004,

15 And upon consideration of the affidavit in support of entry of judgment, the files
16 and pleadings herein and good cause appearing therefore,

17 IT IS HEREBY ADJUDGED that the Plaintiff have and recover from the
18 Defendant, the principal sum of \$3,500.00, statutory damages of \$1,000.00, prejudgment interest
19 from June 18, 2003 to September 24, 2004 in the sum of \$275.00, costs and Disbursements in the
20 amount of \$199.00, and attorney's fees of \$1,000.00 for a total Judgment of \$5,974.00 less
21 payments received in the amount of \$4,000.00 leaving a principal sum of \$1,974.00 together with
22 interest thereon at the rate of SIX AND 25/100 PERCENT (6.25%) per annum or the highest rate
23 allowed by law, whichever is greater from the date of this Judgment until paid in full.
